

CATERING INFORMATION AND TERMS CONTRACT

- 1. FOR ALL EVENTS, A DEPOSIT OF \$100.00 MUST BE MADE TO SECURE ALL CATERING DATES. THE \$100.00 WILL BE DEDUCTED FROM THE FINAL CATERING BILL. OTHERWISE, THE \$100.00 DEPOSIT IS NON-REFUNDABLE. NO DATE SHALL BE HELD UNTIL RECEIPT OF THE NON-REFUNDABLE DEPOSIT.
- 2. FOR ALL EVENTS, A DEPOSIT OF 50% OF THE TOTAL ANTICIPATED CONTRACT PRICE (INCLUDING ANY \$100.00 RETAINER FEES) MUST BE MADE 30 DAYS PRIOR TO YOUR CATERED EVENT. PAYMENT IN FULL IS DUE THE DAY OF THE EVENT UPON DELIVERY OF THE FOOD. THAT PAYMENT MUST BE MADE IN CASH OR <u>BUSINESS</u> CHECK. PERSONAL CHECKS OR CREDIT CARDS CAN BE USED FOR THE FINAL PAYMENT BUT MUST BE RECEIVED 7 DAYS PRIOR TO THE EVENT. THERE WILL BE A \$50.00 FEE ON ALL RETURNED CHECKS. NO <u>PERSONAL</u> CHECKS WILL BE ACCEPTED THE DAY OF THE EVENT.
- 3. ALL MENU ITEMS DO NOT INCLUDE 6% SALES TAX.
- ALL CATERING ORDERS PAID WITH A CREDIT CARD THAT EXCEED \$300.00, ARE SUBJECT TO A NONREFUNDABLE 3% SERVICE FEE.
- 5. MENU SELECTIONS AND A FIRM NUMBER OF GUESTS TO BE BILLED ARE DUE 10 DAYS PRIOR TO THE EVENT.

- 8. WE GUARANTEE THAT YOUR "GUEST COUNT" WILL BE SERVED. IT IS NOT OUR RESPONSIBILITY IF YOU UNDER ESTIMATE YOUR "GUEST COUNT". WE SUGGEST THAT IF YOU KNOW THAT YOUR GUESTS ARE HEAVY CONSUMERS, YOU ADJUST YOUR "GUEST COUNT" ACCORDINGLY.
- 9. ALL CATERING EVENTS ARE "RAIN OR SHINE" EVENTS. IT IS THE CUSTOMER'S RESPONSIBILTY TO PROVIDE SUITABLE SHELTER FOR THE EVENT IN CASE OF INCLEMENT WEATHER.

- 10. BAD BONES BBQ, LLC WILL NOT BE RESPONSIBLE FOR CIRCUMSTANCES BEYOND CONTROL WHICH SHALL PERMIT US TO COMMITTED TIME SCHEDULES OR EVEN CANCELLATION DUE TO SUCH THINGS AS WEATHER, TRAFFIC, ACCIDENTS, EQUIPMENT MALFUNCTIONS, HEALTH, NATURAL DISASTERS, NATIONAL EMERGENCIES, ETC. BAD BONES BBQ, LLC WILL DO THEIR BEST TO REMEDY ALL UNFORESEEN CIRCUMSTANCES BEYOND THEIR CONTROL.
- 11. ALL LEFT-OVER FOOD WILL BE LEFT WITH THE CLIENT. BAD BONES BBQ, LLC IS <u>NOT</u> RESPONSIBLE FOR THE SAFETY AND QUALITY OF SAID FOOD AFTER IT LEAVES OUR SUPERVISION AND CARE.
- 12. BAD BONES BBQ, LLC WILL NOT SUPPLY GUEST TABLES, CHAIRS, LINENS OR COOLERS. WE DO NOT SUPPLY TABLES FOR THE FOOD ITSELF, IT IS THE RESPONSIBILTY OF THE CLIENT. WE WILL SUPPLY THE NECESSARY WARMING PANS, STERNOS AND FOOD SERVING UTENSILS IF AGREED UPON FOR ADDITIONAL FEES (PLEASE SEE #7). PAPER PRODUCTS, UTENSILS, CUPS, AND BEVERAGES ARE THE RESPONSIBILITY OF THE CLIENT UNLESS OTHERWISE AGREED UPON AT ADDITIONAL FEES.
- 13. PRICES ARE SUBJECT TO CHANGE AT ANY TIME WITHOUT NOTICE UNLESS A PRICE HAS BEEN GUARANTEED IN WRITING AND DEPOSIT HAS BEEN RECEIVED.
- 14. WE <u>DO NOT</u> SUPPLY SERVERS. IF WE DELIVER THE FOOD, WE WILL SET-UP THE BUFFET LINE WITH THE APPROPRIATE PANS AND WARMING DEVICES ALONG WITH SERVING UTENSILS IF AGREED UPON FOR ADDITIONAL FEES. BAD BONES BBQ, LLC IS <u>NOT</u> RESPONSIBLE FOR ANY FOOD BEING SERVED WHICH IS NOT PART OF THE AGREED UPON CONTRACT.
